## **MINUTES**

CALL TO ORDER: Board President Bob Carter called the meeting to order at 10:05 a.m.

READING OF ANNUAL MEETING JANUARY 13, 2020 MINUTES waived: Steve Croft motioned to approve the Minutes, Kevin Kelly seconded, and it was approved.
