- 8. ELECTRICAL SURCHARGE TO OWNERS: Kevin noted that Owners in D Building were using Condominium electric lines to power dehumidifiers in their cars while owners were away. Since this electricity is paid for by all owners, owners who do this are asked to contribute \$50 per season to the PBV Social Committee to cover their personal electrical use in garages. Owners can contact Jerri Ives (G-56) to contribute.
- 9. NEW ROOFING and Special Assessments: The board agreed that our roofs need replacing ASAP, and approved Resolution 6 that will allow PBV to at least replace roofs with new shingles and membranes, and also that the board will ask owners at the January 8, 2024 owners meeting to instead upgrade to metal roofs. The board will meet again in two weeks to approve a special assessment for \$470,000 to cover costs of new shingle roofs. Pending owner approval of metal roofs at the January 8, 2024 owners meeting, the board would then approve a supplement special assessment of \$375,000 to cover the added costs.
